Steve Haughn, St Marys

Ms. Dubose presented the board with a handout showing that the majority of the lights at the pickleball court, at Howard Peeples Park are not properly working. Only 10 out of 64 sections are currently working. Ms. Dubose has been discussing the situation with Executive Director Johnsen. Mr. Johnsen said the issue was lightning and later a warranty issue. Ms. Dubose stated the area surrounding each pickleball court has some places that are coming apart.

Also, the batteries are beeping on the AED which is stored in the pickleball shed. Executive Director Johnsen asked Mrs. Dubose to bring the AED to the Rec Center and he will replace the batteries.

Chairman Landreth asked the pickleball group where they would like courts in the future. They agreed that St. Marys would be the logical choice since there are 8 courts in Kingsland.

Ms. Smiley addressed the board concerning the AED and how very crucial every minute is when someone needs an AED.
